The international specialist for solar power plants in the megawatt segment is active as a developer, constructor, operator and investor of large-scale solar power plants. Founded in Hamburg in 2008 as an unlisted stock corporation, the ENERPARC Group now employs over 600 people in its core markets of Germany, Spain, France, Portugal, India and Australia. To date, ENERPARC has successfully connected more than 700 solar plants with an output of over 4.7 GW to the grid worldwide - around 3.5 GW of which are its own solar power plants - and has become one of the largest independent power producers for solar energy in Europe. ENERPARC's goal is to develop a total of 10 GW of PV systems and 1 GW of large-scale battery storage for its own portfolio and a further 10 GW of systems and 1 GW of storage for third-party solar portfolios worldwide by 2030.
